




On 01/12/2021 I responded to the intersection of S Military Trail/Lake Ida Rd as a backup officer for a traffic stop.

Upon making contact with the driver/defendant Mark Traub I suspected that he was under the influence of an unknown alcoholic beverage due to numerous reasons (refer to my DUI PC for further). During my encounter with Traub he advised that he is a retired police officer from New York where he claimed he did 47 years of service as a detective and worked out of the 47th precinct. Traub then retrieved his wallet with a smaller badge that said "City of New York Detective" with the letters "DEA" underneath the badge. After seeing this badge, I asked Traub if he worked for the DEA which he said he did not but he was a detective. I asked him why his badge said DEA if he never worked for DEA which he was unable to provide an answer that made sense. During the roadside tasks, he stated that he never graduated from high school which is a common requirement to become a law enforcement officer.

During my investigation, per Traub's request I called his girlfriend Michelle Mancini to verify if he was ever a law enforcement officer. Michelle stated that he was never a law enforcement officer and that she could not explain what he was. While at PBCJ I contacted Mancini via telephone and obtained a sworn statement on my body worn camera. During the statement, Mancini advised that Traub was never a police officer and that he tells people he was often. Mancini also stated to me that she believes he got the badge from a friend.

While at the PBCJ BAT facility, Traub was read his Miranda Warnings which were recorded via PBCJ recording devices. Traub acknowledged that he understood his warnings. I asked Traub where he got the badge from which he replied "my friend's badge, I'm a family

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Officer Penagos observed the vehicle traveling north in the 400 block of Barwick Rd. Officer Penagos observed the vehicle drive off of the road numerous times into the grassy embankment. Officer Penagos then observed the vehicle make a left (west) turn onto Lake Ida Rd from Barwick Rd at which point he struck the solid median that divides the east/west lanes on Lake Ida Rd. The vehicle then make a right (north) turn onto S Military Trail at which point Officer Penagos initiated a traffic stop and made contact with the driver Mark Traub.

### OBSERVATION OF DRIVER:

The defendant was unable to keep his eyes completely open while speaking with me. The interior of the vehicle had a strong odor of alcohol that I was able to smell from the passenger window. The defendant was drooling from his mouth and also had his left eye partially closed. The defendant's speech was slurred and he was unable to make any sense when speaking to me. The defendant stated that he was going home to a residence that he had been living at for several months but also told me he had no idea where he was. It should be noted that he was very close to his residence. An empty Ice House 24 oz beer can was found under the defendant's driver seat. The can was cold to the touch and the label stated the liquid contained 5.5 percent alcohol.

The defendant stated he had three beers at his friend's house in High Point.

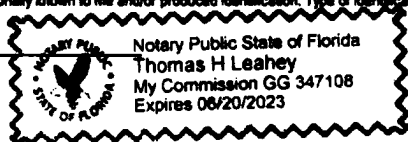

**Other Observations:**

Moved his head several times after being instructed to not move his head and follow the stimulus with his eyes only. The defendant also closed his eyes and swayed off balance.

**WALK & TURN:**

While reading the instructions he began talking about a "Michelle Mancini" even though I instructed him to listen to the instructions. The defendant walked the first set of steps without touching heel to toe with his feet for any of the steps even though I instructed and physically demonstrated how to properly perform the task. During the first set of steps the defendant did not verbalize the number for each step he took as he was instructed to do. The second set of steps, the defendant did not touch heel to toe as he was instructed to do. The defendant verbalized the number of steps and he counted 12 steps even though he was instructed to only count and walk nine steps.

**ONE LEG STAND:**

The defendant stated "I can't do it" when asked if he could complete the task. I then attempted later on to have the defendant complete this task and once again he was looking away while I was explaining the task to him. The defendant also began talking about Michelle Mancini again numerous times while I was reading the instructions for the task. I had to repeat the instructions again prior to beginning the task because the defendant was not paying attention to me. He brought up Michelle once again while I was instructing him. The defendant then closed his eyes and looked at the bushes to my right once he opened them. I told him numerous times throughout the entire investigation to stop looking around and pay attention to me so that he understood the instructions to the tasks.

**FINGER TO NOSE:**

The defendant put his arms outward before I was able to finish the instructions. The defendant then completed the task.

**ROMBERG ALPHABET:**

The defendant then elected to count numbers and I instructed him to count from 30-60. The defendant counted properly and once he counted to 60 he then verbalized "period" and "exclamation point."

Additionally, I informed the driver that if he or she holds a CDL, or was operating a CMV, refusal will result in the disqualification of the Commercial Driver's License/driving privilege for a period of one (1) year in the case of a first refusal or permanently if he or she has previously been disqualified as a result of a refusal to submit to any such lawful test. Nonetheless, the driver refused to submit to the test(s) requested.
