The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 23 day of NOVEMBER, 2019, at approximately 10:45 PM, at US HWY 19 N & SR 580, in Pinellas County did:

THE DEFENDANT UNLAWFULLY OBSTRUCT OR OPPOSE, A DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICER OF THE OFC. TEJERA OF THE CLEARWATER POLICE DEPARTMENT, WHILE IN THE LAWFUL EXECUTION OF A LEGAL DUTY, WHICH CONSISTED OF TRAFFIC STOP WITHOUT OFFERING OR DOING VIOLENCE TO THE PERSON OF THE OFFICER.

ON THE ABOVE DATE AND TIME, I INITIATED A TRAFFIC STOP ON A WHITE HYUNDAI ELANTRA (BEARING FLORIDA #AKY89) NEAR THE AREA OF US HIGHWAY 19 N. AND STATE ROAD 580. THE VEHICLE WAS TRAVELING EXTREMELY SLOW AND IMPEDING THE FLOW OF TRAFFIC AFTER PULLING OUT OF THE COUNTRYSIDE MALL. AFTER INITIATING MY EMERGENCY LIGHTS, THE VEHICLE CONTINUED TO TRAVEL EXTREMELY SLOW AND THE DEFENDANT WAS UNAWARE THAT I WAS BEHIND HER UNTIL I ACTIVATED A SIREN. AFTER ACTIVATING MY SIREN, THE DEFENDANT SIGNALLED THAT SHE WAS GOING TO PULL OVER BUT CONTINUED EAST ON SR 580 FOR APPROXIMATELY ONE HALF OF A MILE. AFTER COMING TO A STOP, I APPROACHED THE DRIVER AND ASKED FOR HER DRIVER'S LICENSE. HER EYES WERE BLOOD SHOT AND I COULD SMELL A STRONG ODOR OF ALCOHOL COMING FROM HER BREATH. WHILE RUNNING THE DEFENDANT'S INFORMATION DURING THE TRAFFIC STOP, THE DEFENDANT DECIDED TO EXIT HER VEHICLE AND BEGAN TO STUMBLE AND STAGGER AS SHE WALKED AWAY FROM HER VEHICLE. I INSTRUCTED THE DEFENDANT TO GO BACK TO HER VEHICLE SEVERAL TIMES WHILE I CONTINUED THE TRAFFIC STOP BUT SHE REFUSED. THE DEFENDANT INSISTED THAT SHE WAS CLOSE TO HER HOUSE AND WAS GOING TO WALK THERE BECAUSE SHE WAS TIRED. THE DEFENDANT MADE INCOHERENT STATEMENTS AND CONFUSING STATEMENTS AND REFUSED TO GO BACK TO HER VEHICLE AS INSTRUCTED. SHE THEN STARTED TO WALK OFF AND SAID THAT SHE WAS WALKING HOME. I THEN TOOK HER INTO CUSTODY AND WHILE TAKING HER INTO CUSTODY SHE TENSED UP, PULLED AWAY AND REFUSED TO PUT HER HANDS BEHIND HER BACK TO COMPLY.

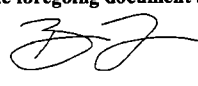

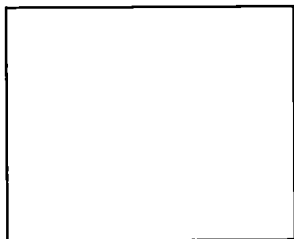
