The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On Tuesday, October 12, 2021, at approximately 12:20 am, at the Seminole Hard Rock Hotel and Casino, Tampa, Seminole Police Department (SPD) Officer A. Conran responded to the valet area (front of casino) after receiving a call for assistance from casino security in reference to an uncooperative, intoxicated subject. Upon my arrival, I observed several security personnel out with a white male subject. I approached and was advised by casino security that the male subject had been cutoff from one of the bars inside and was being refused service for more alcohol. Furthermore, security advised that the subject had been violating a casino policy of recording inside of the casino and refused to stop recording at every request. Casino security made numerous attempts to assist the subject to his Hard Rock hotel room and he continuously refused to go to his hotel room for the night. Myself and other SPD Officers made numerous attempts to talk the subject into cooperating with security and going to his hotel room for the night, all of which were unsuccessful. The subject also refused to cooperate with SPD and continuously argued with Officers and security. The subjects wife, who appeared sober, was also present and attempted to reason with him, which was unsuccessful. Casino Security Supervisor E. Latimer ultimately advised SPD that she, on behalf of the Hard Rock Casino, wished to trespass the subject and for him to leave property for the night. This Officer witnessed Casino Security Supervisor Latimer advise the subject that he was being trespassed from the casino property and that he needed to collect his personal property and leave. This Officer, and SPD Officer B. Hartzig, also advised the subject numerous times that he was being trespassed by the casino and needed to leave property, as the casino no longer wanted him there. The subject refused and argued with Officers and security. All attempts made to get the subject to leave property with his sober wife were refused and unsuccessful. The subject was subsequently placed under arrest, handcuffed behind his back and double-locked. He was positively identified as Marlen Mustafae, date of birth: 09/10/1984, New York driver's license number 213951842. Mustafae was transported to the Orient Road Jail without incident, where he was booked in for the charge listed in this document.
