PROBABLE CAUSE

On May 5th, 2017 at approximately 12 55pm, I arrived on scene of a traffic stop with Tpr Fleurant eastbound on I-75N at mile marker 37 in Broward County. From the front of Tpr Fleurant's patrol car I could detect an odor of cannabis coming from the vehicle. Tpr Fleurant confirmed the smell coming from the white in color 4-door Mercedes occupied by three people. The male driver was asked to step out of the vehicle and was explained his citation. Subsequently, the occupants were placed and handcuffs for temporary detention for the duration of the vehicle search. The female in the right rear passenger was identified by her not valid FL DL (I263543669430) as Marlene Claudia Izquierdo. During a search of the vehicle a dark brown purse was located in the back seat in close proximity to where Ms. Izquierdo was sitting. Located in the purse among personal items (make up, bank cards) was a daily pill container. In that blue pill container there were 7 different pills all without a prescription. Each type of pill was in a separate portion not for daily organization of consumption. From my training and experience that is indicative of abuse and/or sale. Ms. Izquierdo was read Miranda warning and consented to answering questions. She stated those were all her pills in her purse. Although she did not have prescription, she could tell me what they were for. She stated she received them all from a doctor. Ms. Izquierdo was instructed that she was unlawfully and illegally carrying prescription pills. The pills in question were a about 20-white circular pill with SZ199 stamped on them, identified as Lorazepam. The 2nd set of 4- circular pills with LCI1330 stamped on them, identified as Baclofen. The last set of 2-pills were brown rectangular with 325 printed on them identified as Tramadol. All pills were identified using Drugs.com Pill ID. Ms. Izquierdo was transported to Broward county jail without incident.

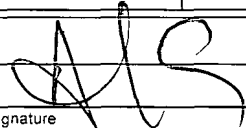

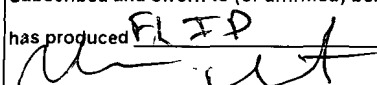
