The defendant was driving a silver 2012 Hyundai Accent (FL Tag #46AJXV) northbound on Dale Mabry Hwy, when the vehicle in front of her moved over, clearing her lane of travel. Once clear, she rapidly accelerated to over 100 mph. This section of Dale Mabry Hwy N is a posted 45 mph zone.

During the traffic stop for her reckless driving behavior, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, largely dilated pupils, blank/dazed stare, slurred speech, she appeared tired/lethargic, was confused with her paperwork, admitted to drinking "3 tequila & pineapple drinks" prior to driving and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs.

While at CBT, she willingly provided 2 valid breath samples after being read Implied Consent, measuring .103/.105 BrAC.
