


Sterk #1943 whom advised Marley was involved in a hit and run traffic crash in the area of Presidential Way/N. Congress Avenue, at approximately 2347 hours, where she was injured and transferred to JFK North Hospital to treat her injuries (WPB Case #2021-0011448). While on scene, Marley advised officers that [REDACTED] where at [REDACTED] alone sleeping and requested units go by the residence to conduct a welfare check. Officer Sterk advised Marley provided the key to the front door of the residence and gave permission for officers to enter the home. Officer Sterk and Officer C. Stripling #2037 arrived at the residence at approximately 0011 hours to conduct a welfare check on the children. Both children, later identified [REDACTED] (W/M 02/28/2016) and [REDACTED] (W/F 11/19/2017), were located upstairs in their bedroom sleeping together in bed.</p> <p>While on scene, subject Jack Hohman (W/M 11/03/1993) responded to the residence from the traffic crash and identified himself as Marley's current boyfriend. Jack stated he moved in with Marley approximately three (3) weeks prior and currently resides at the residence with Marley and [REDACTED]. Jack advised he has been dating Marley for approximately one (1) month but has know her for several years.</p> <p>Hohman advised they placed the children to bed sometime before midnight and shortly after left the residence to go to his friend's house, located at 1731 Presidential Way #C202, to pick up a guitar cable and equipment. Hohman advised they were suppose to go and come right back; however they never made it to their destination due to the traffic crash. Hohman advised at the time of their departure from the residence he had no</p>

knowledge of any person that was left behind to supervise the children while they were away. Hohman advised Marley could have mentioned an arrangement but he is unsure.

Officer J. Taveras #2179 advised that while conducting his traffic crash investigation at the hospital; Marley advised she left the children in the care of a neighbor by the name of "Kerry". Marley stated "Kerry" is all she knows her neighbor by and if facing the front gate of her (Marley's) residence then "Kerry" would be in the residence directly to the left.

Officer M. Annese #1418 and I attempted contact with "Kerry" at [REDACTED] and she was located inside the residence. "Kerry" provided me with a sworn taped statement and advised her name is actually Mary Caroline Higgins (W/F 03/02/1964) and Kerry is her nickname. Higgins advised that she has watched the [REDACTED] once in the past approximately one month prior to today's incident, however; she had not spoken the Marley or anyone at anytime tonight about supervising the children while Marley left the residence. Higgins advised she had not spoken to Marley in person or via phone at anytime today. Higgins also advised she checked her phone log and did not see any phone calls from Marley at this time.

I then responded to JFK North Hospital to make contact with Marley whom was tending to her injuries sustained in the traffic crash. Post Miranda, Marley advised as she was leaving her residence she spoke with Higgins on their joint walk-way in reference to watching [REDACTED] (Marley's) residence and [REDACTED] due to them sleeping inside. Marley stated Higgins was walking her dog and she asked if Higgins could remain on her unlocked gated front patio just in-case the children woke up. Marley stated she told Higgins to call her cell phone if she needed for Marley to return for any reason due to the front door of the residence being locked and Marley did not leave a key. Marley advised Higgins agreed and was last seen walking into Marley's unlocked gated front patio prior to her departure from the residence in her vehicle.

Marley also advised she was leaving with her boyfriend (Hohman) to get some unknown items from his friends residence. Marley advised she does not remember the address they were en-route to due to utilizing a GPS and her phone was currently without any battery power. Marley stated the plan was to retrieve the items and return home as quickly as possible.

Based upon the above facts and statements Marley Arielle Ortinau did fail or omit to provide [REDACTED] and [REDACTED] both children, with the care, supervision, and services necessary to maintain the child's physical and mental health, including, but not limited to, food, nutrition, clothing, shelter, supervision, medicine, and medical services that a prudent person would consider essential for the well-being of the child, and Marley Arrielle Ortinau was the [REDACTED]. Subsequently I find probable cause exists to arrest and charge Marley Arrielle Ortinau
