**PERSONAL CONTACT**

### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Upon arrival in my black and white marked "Palm Beach Gardens Police" vehicle I made contact with Officer Timothy Connors #201 and Officer Benjamin Triana #407. Ofc. Connors later advised he was dispatched to the scene after a passing motorist called police advising a black Mustang was stopped at the intersection and had not moved after a few light cycles. Ofc. Connors was first to arrive and positioned his vehicle nose-to-nose and attempted to make contact with the driver, a white male wearing a maroon shirt and blue jeans, who was slumped over in the driver's seat. Ofc. Connors noted the Ford Mustang, bearing Florida Tag L7AGA, was still in drive and the driver, later identified via his Florida Driver's License as Marlin Ellison, had his foot on the brake. After multiple attempts to wake Ellison up, Ofc. Connors utilized his department issued lockout kit and made entry into the vehicle and secured the vehicle in park. Ofc. Connors, utilizing a sternum rub, attempted to wake Ellison up, however he was not responding and requested Palm Beach Gardens Fire Rescue to respond to the scene. Fire Rescue was able to wake Ellison up after their arrival and subsequently him to Palm Beach Gardens Medical Center for medical evaluation. I followed the ambulance to the hospital and Fire-Medic Daniel Duval advised Ellison was not administered any medications and Ellison made no comments to Fire Rescue personnel about the incident.

### OBSERVATION OF DRIVER:

Ellison had no recollection of driving or attempting to drive home, the scene at Northlake Blvd and Interstate 95 or the ambulance ride to the hospital. While talking with Ellison, he continually had a blank stare and was lethargic. Ellison had the strong odor of an unknown alcoholic beverage coming from his breath as he spoke. His clothing, maroon Polo shirt, ripped blue jeans and white tennis shoes were clean, with the exception of a blood stain possibly obtained by the IV Fire Rescue put in his right arm. Ellison's eyes were glassy, watery and bloodshot and he spoke with a slur and mumbled.

### DRIVER'S STATEMENTS:

In the hospital room, Ellison acknowledged he was at a hospital, however believed an Uber dropped him off. Ellison did not have any recollection of being transported by ambulance to the hospital. Ellison claimed he had been in an Uber and continually denied driving. Ellison stated he was at Clematis where he drank alcohol and realized he "needed to get a ride" and claims he took an Uber to his friend's house in Gables of Montecito. Ellison stated he left Clematis around 02:00 or 03:00. Ellison stated he does not recall the specific address to his friends, however knows "they both" took an Uber to the house. Ellison later stated he was supposed to stay the night, however claimed he ordered an Uber to take him home.

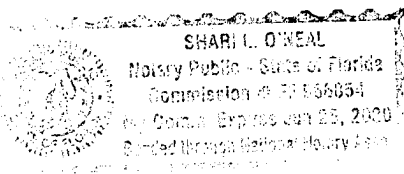

**Other Observations:**

Vertical gaze nystagmus was found. I also observed Ellison's eyes to be bloodshot, watery and glassy. Ellison had a visible sway.

**WALK & TURN:**

The instructions were explained and demonstrated to Ellison. After instructions and Ellison stating he understood, Ellison started on command. Ellison took the incorrect number of steps, completing 10 steps. Ellison did not turn as instructed and demonstrated. Ellison stopped performing the task and had to be reminded to complete the exercise. Ellison walked off the line on step 2. Although Ellison miscounted, he took the correct number of steps. Ellison raised his arms more than six inches during the task.

**ONE LEG STAND:**

The instructions were explained and demonstrated to Ellison, who stated he understood. During the instructional phase, Ellison began the task unprompted. Upon the command to begin, Ellison swayed while balancing. Ellison raised his arms more than six inches to maintain balance. Ellison stopped at 1000-10, having to be told to continue with the exercise. At 1000-14, Ellison raised his leg higher and put a bend in his knee, nearly making a 90-degree angle with his leg to complete the task. I instructed Ellison to straighten his leg and foot, which he did. Upon telling him to stop, Ellison continued to leave his leg raised.

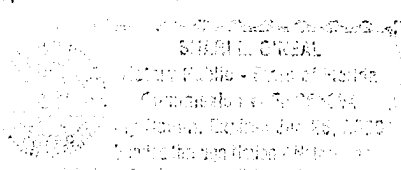
