DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.

On 08/27/21 at 0022hrs Ofc. Musliu #1202 DBPD observed a silver 2016 Toyota Rav4 (FL Tag #168YJI) traveling north on Old Dixie Hwy. north of W. Linton Blvd. The Toyota left and re-entered the northbound travel lane several times. The Toyota turned right onto SE 10th St. and continued east. The Toyota approached the intersection of SE 5th Ave. with eastbound traffic having a steady red traffic signal. The Toyota did not stop prior to the stop bar before entering the intersection. The Toyota came to a complete stop in the middle of the intersection directly in the path of the southbound travel lanes. After stopping, the Toyota made a right turn (south) onto SE 10th St. Ofc. Musliu activated her emergency lights of her DBPD patrol vehicle and conducted a traffic stop just south of SE 10th St. Ofc. Musliu met with the white male driver and identified him by his FL DL as Martin James Ford III. Ford III was sitting in the driver seat, with the engine running and vehicle key in the ignition. There was nobody else inside the Toyota. I arrived on scene and identified Ford III by his FL DL. I informed Ford III I was on scene to conduct a DUI investigation and he stated he understood. In plain view on top of the Toyota's front passenger seat was an open Miller Lite beer can in a Taco Bell plastic bag.

OBSERVATION OF DRIVER:

I smelled an odor of an unknown alcoholic beverage coming from Ford III. Ford III's eyes were red and had a glassy appearance. Ford III's speech was slurred while he was speaking. Ford III was sweating and had a slow dexterity. Ford III refused to perform roadside tasks and I informed him of Taylor Warning. Ford III stated he understood Taylor Warning and again refused to perform the requested roadside tasks. Ford III was agitated due to being stopped so close to his residence. For the majority of the incident Ford III was polite and respectful. After arrest was made, Ford III swayed while standing still.

DRIVER'S STATEMENTS:

Ford III stated he started driving at Taco Bell (240 W. Linton Blvd. Delray Beach, FL.) where he purchased six tacos. Ford III stated he was on his way home when he when the traffic stop was conducted. I asked Ford III if he knew why he had been stopped and he replied "because of weaving and that traffic light right there" as he pointed toward the intersection. I asked Ford III if he had any medical conditions that would affect his ability to operate a motor vehicle and he replied "not that he knew of". Ford III denied taking any prescription medications. I asked Ford III if he had consumed/used any illegal drugs including and he replied "not that he knew of". I asked Ford III how much alcohol had he consumed tonight and he replied "not that he knew of". Ford III stated he had no problems with his eyes that were not corrected by glasses. Ford III stated there was no reason his eyes should be red and have a glassy appearance. Ford III stated there was no reason why I smelled an odor of an unknown alcoholic beverage coming from him. I asked Ford III about the open beer can that was inside a Taco Bell bag on the passenger seat and he replied "he put it there because he was scared". Ford III stated the beer can was in the center console before he put it in the bag. I asked Ford III if there was beer still inside the can and he replied "it is an open container in a vessel". Ford III initially stated the beer can came from a tailgate from earlier in the night. I asked Ford III where the tailgate was at and he replied "the tailgate was not tonight, that he bought tacos tonight". I asked Ford III if his wife drinks Miller Lite and he replied "No". I asked Ford III who then would put a Miller Lite can in the vehicle and he did not give a response. Ford III again stated "it is an open container in a vessel and I know the law".

If you fail to submit to the test I have requested of you, your privilege to operate a motor vehicle will be suspended for a period of one (1) year for a first refusal, or eighteen (18) months if your privilege has been previously suspended as a result of a refusal to submit to a lawful test of your breath, urine or blood. Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
