The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 4/10/2021, at approximately 1933 hours, the defendant was operating a White Dodge pickup truck, bearing FL tag YJ6ID (VIN: 3C6JD6AT5CG254296), and was slumped over the steering wheel while the vehicle was still in "D" Drive. Deputy M. Holland #5001 responded and placed her marked patrol, bearing tag ZNB91 (VIN: 2C3CDXAG1KH645023), vehicle directly in front of the defendant's vehicle. In an effort to gain the defendant's attention, the defendant released his foot off the brake causing the front of the defendant's vehicle to strike the front of Deputy Holland's patrol vehicle. Due to the defendant's action, there was approximately \$200.00 in damages between both vehicles. (HCSO CAD call 21-232404, DHSMV crash #89446626) Affiant responded to the scene, detected signs of impairment from the defendant, which were blood shot watery eyes, distinct odor of an alcoholic beverage emitting from his breath, and the defendant was unsteady on his feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to perform. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a breath sample, which was .203/198. The defendant was identified via Florida Driver License. The defendant was given DUI citations, AE94Q7E and AE94Q8E, which reflects the DUI charges.
