The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On Sunday September 5, 2021, I, Officer Malachi Wilkins of the Florida Fish and Wildlife Conservation Commission was on state water patrol in Hillsborough County, Florida. At approximately 1500 hours I observed a vessel being operated by the defendant near Gandy Boat Ramp. At the time I observed the defendant operating the vessel he was the only one onboard and was in complete physical control of the vessel. I pulled the defendant over in order to conduct a vessel safety inspection at the Gandy Boat Ramp. I identified myself and the reason for the stop. During the vessel safety inspection, I observed the defendant's eye to be bloodshot. I also had to remind him several times for the various safety equipment items. I asked the defendant if he had consumed any alcohol and he said that he did not. I then asked him if he would consent to performing seated field sobriety tasks and he said that he was willing to do so. During the field sobriety tasks the defendant performed poorly and was placed under arrest for boating under the influence. He was then transported the FWC Tamp Field Office where he was read his implied consent. The defendant stated that he was willing to provide a sample of his breath. After a 20 minute observation he provided samples of .009 and .009. Officer Zach Hoppe who is a certified Drug Recognition Expert (DRE) performed A DRE evaluation on the defendant. The defendant provided a sample of his urine and the results are pending per testing from FDLE.
