This incident occurred in the City of Delray Beach, Palm Beach County, FL:

On 02/06/2021 I responded to 32 SE 1st Ave unit 147 (Worthing Place Apartments) in reference to a disturbance.

Upon arrival, I made contact with reporting party/Worthing Place Apartments Security Guard Ceus Obed. Obed advised that white male Matthew Shelton arrived at the complex and began cursing at him when he entered the building. Obed advised that this is an on going issue with Shelton causing a disturbance with him when he arrives home. Obed explained that he was able to locate Shelton's apartment so that he can forward the unit number to the police for a police report when we arrived. Obed further advised that he watched from a distance as Shelton arrived at his apartment and when they were closer to apartment 147 Shelton stated that he would shoot him.

After speaking with Obed, I was standing in front of unit 147 and confirmed that this was the subject's apartment at which point Obed confirmed it was. I knocked on the door wearing my full Delray Beach Police Department marked police uniform. The subject aggressively opened the door quickly at which point I looked into the apartment. It should be noted that there is a peep hole on the door that would have allowed an occupant of the apartment to see that police officers in full police uniform were knocking at his door. As I looked into the residence to make contact with the resident, I immediately observed a white male with an angry look on his face holding a black handgun in his right hand that was pointed directly at me. I was in great fear that the subject was going to fire his weapon at me and take my life at which point I drew my DBPD department issued handgun and pointed it at the subject. I immediately gave the subject numerous loud verbal commands to put the gun down which he refused to comply with. The subject eventually began to slowly lower the gun but refused to relinquish control of the gun like he was ordered to do so numerous times. Officer Bruno and I gave

more loud verbal commands for the subject to put the gun down and get on the ground at which point the subject began walking backwards while the gun was still in his right hand. I then approached him and grabbed the gun from his right hand and placed it on the kitchen counter while Officer Bruno escorted the subject to the floor. Once the subject was taken into custody he was then identified by FL DL as Matthew Shelton (07/25/1958). It should be noted that this is the same subject that threatened the reporting party Obed.

After Shelton was safely in custody, I began to speak with him. Shelton stated that he had no idea who was knocking at his door.

Due to the above stated facts, I find probable cause to charge Matthew A Shelton with Aggravated Assault on LEO pursuant to FSS 784.07(2C), Aggravated Assault With A Firearm pursuant to FSS 784.021(1)(A), and Disorderly Intoxication pursuant to FSS 856.011.
