On 08/11/2019 at 0247 hours I conducted a traffic stop on a grey 2017 Nissan sedan, FL tag GKLG91 after I observed it traveling the wrong way on a one way street, S/B on Howard Av S from Kennedy Bl W. Upon contact with the driver, defendant Conklin I observed that he had glassy bloodshot eyes and a yellow paper bar wrist band on his right wrist. Then as I spoke with him I began to detect the distinct odor of an alcoholic beverage. When I asked him how much did he have to drink that night he replied "not much". The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based on all of my observations made thus far in my investigation. The time of arrest was 0256 hours. While searching the defendant after arresting him I found a small clear baggie of a white powdery substance in his wallet. I then field tested the powdery substance and it tested positive for cocaine. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .240/.221. I identified the defendant with a suspended FL DL. His FL DI was suspended on 03/20/2019.
