The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 17 day of FEBRUARY, 2020,

at approximately 4:40 PM, at 30144 US HWY 19 NORTH CLEARWATER, FL 33761, in Pinellas County did:

DID UNLAWFUL TO POSSESS, OR USE OR ATTEMPT TO USE, ANY ANTISHOPLIFTING OR INVENTORY CONTROL DEVICE COUNTERMEASURE WITHIN THE PREMISES OF HOME DEPO LOCATED AT 30144 US HWY 19 N WHICH IS USED AS A RETAIL STORE FOR THE SALE OF GOODS AND MERCHANDISE.

WHILE INVESTIGATING THE DEFENDANT FOR FELONY RETAIL THEFT AT THE OCCURRED, IT WAS DISCOVERED THE DEFENDANT WAS OBSERVED BY THE LOSS PREVENTION OFFICER TAMPERING WITH THE ANTI-THEFT DEVICES. DEFENDANT WAS OBSERVED USING A RED MILWAUKEE FOLDING POCKET KNIFE TO CUT OPEN MULTIPLE PACKAGES AND BY REMOVING ITEMS WHICH HE CONCEALED IN HIS POCKETS WHILE INSIDE THE STORE. PRIOR TO EXITING THE STORE WITH THE ITEMS REMOVED FROM THE PACKAGES, THE DEFENDANT IS OBSERVED DISCARDING THE ITEMS AND WRAPPERS AFTER HE OBSERVED LAW ENFORCEMENT. AFTER CONTACT WAS MADE JUST OUTSIDE THE STORE, THE DEFENDANT WAS IN POSSESSION OF A RED MILWAUKEE POCKET KNIFE AND NONE OF THE OTHER ITEMS HE ATTEMPTED TO STEAL. THE DEFENDANT WAS POSITIVELY IDENTIFIED BY THE LOSS PREVENTION OFFICER. PRIOR TO BEING QUESTIONED ABOUT THE INCIDENT, THE DEFENDANT ADMITTED TO ATTEMPTING TO STEAL THE ITEMS BUT STATED HE WAS ASHAMED OF HIS ACTIONS AND COULDN'T COMPLETE THE ACTION.

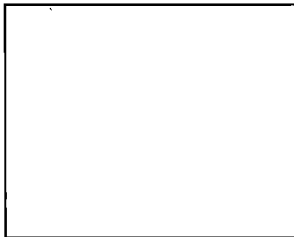
