On 08-28-2021 at approximately 1846 hours, your affiant observed the defendant operating his vessel within the Alafia River approaching the Williams Park Boat Ramp. The vessel was stopped for the purposes of conducting a boating safety inspection. Your affiant did not observe any properly placed Boating Safety Inspection Decal(s) affixed to the vessel. Your affiant noticed the odor of an alcoholic beverage coming from the defendant's breath and he had slurred speech. Your affiant observed alcoholic beverages aboard the vessel to included an open beer can in a cup holder at the helm of the vessel. Your affiant asked the defendant to conduct SFST's which he agreed to. The defendant showed signs of impairment and was arrested for boating while normal faculties impaired (BUI).
