On the listed date and time, at Bloomingdale Av / 301 Hw S within Hillsborough County, Corporal B. Dobson #4809 contacted the driver on a traffic stop for failure to maintain a single lane (citation #AE91QCE). Corporal B. Dobson observed the defendant in the driver seat and sole occupant of the vehicle. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his breath, he had slurred speech, had bloodshot and watery eyes, and an unstable balance. Field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples. The first BrAC sample was .109 and the second BrAC sample was .104. The defendant was identified via a valid Florida DL.
