The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/24/2021 at 0226 hours while traveling northbound on Memorial Hw I observed a gray Honda sedan drift out of its lane of travel and off the the road way multiple times. Then concerned that the driver was either ill, fatigued, or impaired I conducted a traffic stop. Upon contact with the driver, defendant Matthew Perez I observed that he had glassy bloodshot eyes and then as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. When I asked him how much did he have to drink tonight he replied "not that much". The defendant then exhibited additional signs of impairment during the standardized field sobriety exercises. At which time I placed him under arrest for DUI based upon on all of my observations made thus far in my investigation. The time of arrest was 0243 hours. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .228/.216. I identified the defendant with a Puerto Rico DL.
