The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a black 2016 Volkswagen Jetta, 4 door, Florida temporary tag CVH6264. The defendant drifted to the right of his travel lane, nearly striking the raised curbing alongside the roadway. The defendant drove in a manner in which the vehicle drifted over painted lane markers several times, and he made the late decision to change lanes thereby driving into and through the large painted (diagonal hash lines) safety zone between two exit ramps on the interstate. This lane change was made in front of another vehicle and without the use of a turn signal. The defendant accelerated to a high speed of 80+ MPH in a properly posted 55 MPH speed limit. The vehicle speeds were visually estimated and were patrol car paced (TPD DUI Unit 5055). A traffic stop was initiated for the speed violation as well as to check on the drivers condition and determine if he were sick, tired, distracted, or impaired. The defendant wore a paper bar admissions band from the Honey Pot on his right wrist. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery, and he had difficulty keeping his eye lids open. The defendant's speech was slurred, and his face was flushed. The defendant denied consuming any alcoholic beverages. The defendant swayed noticeably while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment. Based on a totality of the circumstances, he was placed under arrest for DUI. The defendant provided breath samples of .097% BrAC and .093% BrAC. The defendant was positively identified by his FL DL.
