Christal advised that she got home from work today and her Boyfriend Identified as Matthew Martino (W/M DOB 08/26/1972) was drunk in his apartment. Christal advised that they went to Oshea's for a couple hours as she only had one beer. Christal advised that she picked up his phone when they got home and saw a name by "Tina" on his phone. Christal began to ask him who "Tina" as he then got angry at her and snatched the phone out of her hand. Christal then stated he started to drag her by her hair across the apartment and she started to fight back in order get him off of her. Christal advised that she was screaming as bystanders heard and call police for her as she was unable to. I then made contact with Matthew as he advised me of the following:

Matthew stated that Christal Grabbed his phone and got mad and started to throw things around the apartment. Matthew advised that he has screeches on his face from her but declined medical attention on scepe. Matthew stated all he wanted was his stuff back and for her to leave him alone.

I then made contact with Witness Maureen Costa Ryan (W/F DOB 10/25/1985) as she advised me of the following incident under a Sworn Capacity:
