N Christal advised that she got home from work today and her Boyfriend Identified as Matthew Martino (W/M DOB 08/26/1972) was drunk in his apartment. Christal advised that they went to Oshea's for a couple hours as she only had one beer. Christal advised that she picked up his phone when they got home and saw a name by "Tina" on his phone. Christal began to ask him who "Tina" as he then got angry at her and snatched the phone out of her hand. Christal then stated he started to drag her by her hair across the apartment and she started to fight back in order get him off of her. Christal advised that she was screaming as bystanders heard and call police for her as she was unable to. I then made contact with Matthew as he advised me of the following:

E Matthew stated that Christal Grabbed his phone and got mad and started to throw things around the apartment. Matthew advised that he has screeches on his face from her but declined medical attention on scene. Matthew stated all he wanted was his stuff back and for her to leave him alone.

I then made contact with Witness Maureen Costa` Ryan (W/F DOB 10/25/1985) as she advised me of the following incident under a Sworn Capacity:

Maureen stated that she was having drinking across the street from the above location when she heard screaming coming from the apartment complex. Maureen advised that she heard a Female screaming "HELP" multiple times. Maureen advised that she walked to a police car near by and told the officer what was going on. Maureen then stated the officer began to walk up stairs as she then heard the female say, "Help he is going to kill me". Maureen then asked her for the apartment number as she gave it. Maureen then advised multiple police arrived on scene as the screaming stopped. Maureen added to the statement to say that staff from the business across the street stated, "I hope it's not the regular that says she get beat up by her boyfriend". Maureen stated that she has never seen the female before.

Christal had several injuries to her knees and scratches on her arms and advised that she was hit in the face by Matthew. The Injuries on Matthew were consistent to defensive wounds as it was scratch marks.

Based on the above information Probable cause exist for Matthew Martino (W/M DOB 08/26/1972) for one count of Domestic Battery per F.S.S. 784.03(1A1)
