at approximately 12:06 AM, at RIDGE RD SW/8TH AVE SW, in Pinellas County did:

REASON FOR STOP: DEF WAS OPERATING A RED FORD PICK UP TRUCK WITH FLORIDA LICENSE PLATE "NAR Y52" THAT DRIFTED TO THE LEFT ALMOST STRIKING THE CURB TO THE CENTER MEDIAN. HE THEN DRIFTED TO THE RIGHT WHERE HE ALMOST STRUCK A MARKED LARGO POLICE CRUISER. AFTER OFFICERS ACTIVATED THEIR EMERGENCY LIGHTS TO EFFECT A TRAFFIC STOP, THE DEFENDANT ALMOST STRUCK A TREE IN THE RAISED MEDIAN.

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED.

UPON CONTACT, THE DEFENDANT HAD BLOOD SHOT/WATERY EYES, SLURRED/MUMBLED SPEECH, AND THERE WAS AN ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AS HE SPOKE. WHEN EXITING HIS VEHICLE HE WOULD STUMBLE, STAGGERED AS HE WALKED, AND SWAYED AS HE STOOD ON HIS OWN UNSUPPORTED. POST-MIRANDA, HE SAID HE WAS NOT SURE IF HE WANTED TO SPEAK WITH OFFICERS BUT AGREED TO SFSES WHERE NUMEROUS ADDITIONAL SIGNS OF IMPAIRMENT WERE OBSERVED. WHEN ASKED AGAIN IF HE WANTED TO SPEAK WITH OFFICERS HE TOLD THAT HE THOUGHT THAT IT WAS "NOT IN MY BEST INTEREST." DEFENDANT AGREED TO PROVIDE A BREATH SAMPLE HOWEVER ONCE THE INSTRUMENT WAS READY HE STATED HE DID NOT WANT TO PROVIDE A SAMPLE. I READ HIM THE IMPLIED CONSENT WARNING WHICH HE SAID HE UNDERSTOOD. DEFENDANT AGAIN THEN TOLD ME THAT HE THOUGHT IT WAS "NOT IN MY BEST INTEREST" AND THAT HE WAS "NOT DRUNK" BUT STILL REFUSED TO PROVIDE A BREATH SAMPLE TO DETERMINE ITS ALCOHOLIC CONTENT.

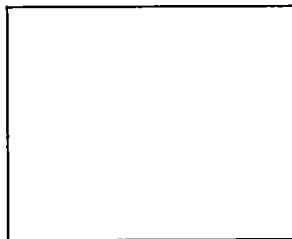
