| <p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did</p> <p>On 9/28/2020, at approximately 0310 hours, Affiant observed a black Chrysler van bearing FL tag N092ZN (VIN:2C4RC1BG7CR330369) conducting an unsafe and illegal U-Turn. The black Chrysler, while traveling in westbound lanes, entered into a left only turn lane located in eastbound lanes of traffic to conduct a U-Turn. Affiant conducted a traffic stop on the vehicle at Bearss Av E / Pinecrest Rd in Tampa, FL and observed the defendant operating and to be the sole occupant of the vehicle. Affiant detected the distinct odor of an alcoholic beverage emanating from his person, his eyes were bloodshot and glassy, and he was lethargic in his movements. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). The defendant refused to provide a lawful breath sample to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of Central Breath Testing, he understood and replied "No." The defendant was identified via FL DL. The defendant was given a DUI citation A95OVEE which reflects the DUI charge.
