The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 04/17/2021 at approximately 1638hrs, Affiant conducted a vessel stop on a 17' white/blue Bayliner bearing FL7844PV/BLBA76CJD313 at the mouth of the Afafia river west of 41 Hwy S Riverview, Hillsborough County, FL 33578 for the purpose of a safety inspection. Upon stopping the vessel, affiant identified himself and made contact with the defendant/operator, who was at the helm of the boat. During personal contact with the defendant, affiant detected and odor of an alcoholic beverage coming from his breath, observed him to have slurred speech and noticed he was unsteady as he moved around his boat. Due to this, affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant refused to perform the SFSTs. Affiant arrested the defendant for boating under the influence and advised him of Florida Implied Consent. The defendant stated he understood and refused to provide a breath sample. The defendant verbally identified himself and produced a Florida drivers license.
