


<p>On 07/27/2021 at approximately 0239 hours, while conducting a security patrol at 701 W Palmetto Park Rd, I observed a black Kia vehicle bearing FL tag DKRD87 driving westbound on W Palmetto Park Rd at approximately the 700 block. I observed this vehicle to be in violation of F.S.S. 316.221(2) for No Tag Light. At approximately 1200 W Palmetto Park Rd, I initiated a traffic stop on this vehicle with my marked police vehicle with activated blue and red lights and sirens. The vehicle came to a complete stop in front of the TD Bank at 1400 W Palmetto Park Rd. Officers Horne, Galazka and Walker responded as backup officers.</p> <p>I immediately made contact with the driver and sole occupant of the vehicle, identified by his FL DL to be Matthew Green. Upon making contact with Green, I immediately observed his eyes to be bloodshot glossy, he was slurring his speech, and his movements were very slow. Further, I observed a couple of "Coors light" alcoholic beverage bottles on the passenger side floor as well as a can of Miller Light alcohol on the passenger seat. I advised him that I had pulled him over because I observed the tag light to his vehicle to be out. While speaking with Green, I could also smell a strong odor of alcohol emanating from Green's breath and person. Green stated that he would be "honest" with me. Upon asking him where he was coming from, he stated he was coming from his buddy's house. I then asked him if he had anything to drink, and he stated he was and had three beers. Upon asking him about the open containers of alcohol I observed on his passenger side floorboard and seat, he advised those were from yesterday. I then requested Green step out of his vehicle so I could speak with him off the roadway in a safe, well-lit area.</p> <p>Green then stepped outside of his vehicle. I asked Green where he lived, and he provided me with the correct address that was on his FL DL. I asked Green if he knew where he currently was, and he stated, "Broward County." I then asked what street he was driving on where I pulled him over, and he stated, "Sample Rd." He continued to sway and have</p>

<p>slurred speech while speaking with me. I then asked if he had any physical injuries or impairments, and he advised he did not. I also asked if English was his first language and if he can read, write, and speak English, and he said yes. I also asked if he needed any glasses or contact lenses to see, and he stated "yes, contact lenses" and he can currently see without issue.</p> <p>At this point, I requested that he perform the standard field sobriety tasks to dispel my alarm he was driving impaired. He provided consent.</p> <p>He stated he did not have any physical injuries or impairments that would prevent him from walking, standing, or balancing. He also stated he was not taking any prescription medications. He also stated his highest level of education is two years of college.</p> <p>I performed and demonstrated each task before he attempted them.</p> <p>The first task was the Horizontal Gaze Nystagmus. After I provided him instructions not to move his head and follow with his eyes only, he continued to move his head. I noticed jerking in both of his eyes at maximum deviation with the stimulus approximately one foot away from his face.</p> <p>The second task was the Walk and Turn. Green did not maintain the starting position as I requested while I explained and demonstrated the task. He could not understand that he had his right foot on the line with his left foot in front after I had put him in the correct starting position with left foot on the line and right foot in front, heel-to-toe. Green took ten steps forward while counting out loud and using his arms up like an airplane to balance himself. He did not maintain heel-to-toe and stepped off the line more than once. He then turned around incorrectly, stopped, and asked, "ready?" He then took nine steps back, but did not count out loud, stepped off the line more than once, and again used his arms to balance. After his ninth step, he stopped, stepped off the line and asked me, "nine, right?"</p> <p>The third task was the One Leg Stand. Green used his arms for balance. He did not count out loud. After I gave him the instructions, he asked me multiple times, "right leg?" He also stated he was going to count as "one 1000, two 1000, three 1000." I then corrected him and explained a second time that I wanted him to count as "1001, 1002, 1003." I then asked Green if he was ready, and he replied, "yes." Green continuously put his foot down and did not count out loud at any point. He also raised his arms to balance himself. He also did not look down at his foot as I instructed. He stated while doing the task, "that's hard though." He also bent his leg and did not keep it straight. After thirty seconds and multiple incomplete attempts, I concluded the task and told him to relax.</p> <p>The fourth task was the Rhomberg Alphabet. Green said he knew the English alphabet and</p>

could finish the task without incident. He recited the alphabet as "a,b,c,d,e,f,g,h,i,j,k,l,m,n,o,p,q,r,s,t,u,v,w,x,y,z". He then stated, "I know the alphabet but I don't know it right now."

The fifth task was the Rhombus Balance (estimate thirty seconds). I showed him prior start what thirty seconds looks like on my timer. He acknowledged he understood the instructions. I then told him to begin. After thirty seconds, he stated it had been thirty seconds.

The sixth task was the Finger to Nose (L-R-L-R-R-L). Upon asking her if he understood the instructions, he stated "yes." On every finger-to-nose, Green would miss the tip of his nose by touching just below his nose and then would touch the tip of his nose.

Based on the information above, I placed Green under arrest for DUI. I handcuffed Green and checked for proper fit and double-locked. Ofc Horne conducted a search of Green's person. During the search incident to arrest, Ofc Horne located a small clear baggie with an unknown white substance in Green's front right pocket. I then placed Green into my police vehicle. I then read Green his Constitutional Warnings from a pre-printed card issued by BRED, and Green advised he understood his Constitutional Warnings and agreed to speak with me without an attorney present. I then asked him what the contents of the small clear baggie with unknown white substance was, and he stated it was "cocaine, just cocaine." Ofc Walker took custody of the clear baggie with unknown white substance for a Department approved field test. Using a Lynn Peavy Quick chest test kit, the kit turned blue giving a positive indication for cocaine. The clear baggie containing the cocaine was weighed to be 0.8 grams. I transported Green to PBCJ for a BAT. Upon arrival to PBCJ BAT, I conducted a 20-minute observation and then Green was taken into the BAT room. Green agreed to provide a breath sample. Green provided two breath samples of 0.159 and 0.153. I then asked Green if he recalls his Constitutional Warnings I read to him on scene approximately sixty minutes prior, and he stated he does. Green then agreed to answer my questions. See DUI Influence report. Matthew Green is being charged under F.S.S. 316.193(4) for DUI (above 0.15). Additionally, Matthew Green is being charged under F.S.S. 893.13(6) (a) for Possession of Cocaine. I also issued Green a DUI citation for Driving While Intoxicated. Green was also issued a written warning citation for no tag light pursuant to F.S.S 316.221(2) which was the reason for the traffic stop. Green's vehicle was inventoried by me and later Ofc Walker. I located a total of six open Coors light alcoholic bottles on the passenger side floorboard, a small opened and partially filled glass bottle of Fireball whiskey in the passenger side door, and a closed Miller lite beer can on the passenger seat. Photos of these beverages were taken on my MVR body camera. Green's vehicle was later towed by Emerald towing (see Ofc Horne, Ofc Galazka, and Ofc Walker's supplement reports for further details.)

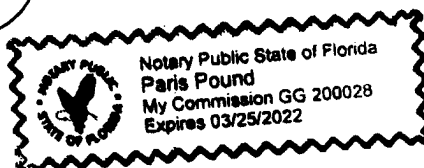

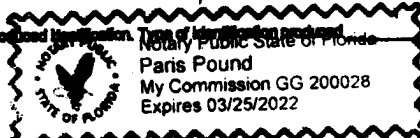
