County Sheriff's Office on a traffic stop located on southbound Interstate-95 (State Upon my arrival I met with Palm Road 9) just south of Donald Ross Road. Beach County Sheriff Cpl. Mike Dallesandro # 8297. Cpl. Dallesandro stated he was entering southbound Interstate-95 from the entrance ramp from State Road 706 (Indiantown Road) in his department issued unmarked Ford Explorer. Dallesandro stated that a white in color Dodge Charger (FL license "01JZI") was traveling at a very high rate of speed and passed Cpl. Dallesandro using the right shoulder on the right side of the single entrance lane as it merges onto southbound The white Dodge Charger then veered to the left crossing directly Interstate-95. in front of Cpl. Ballessandro's vehicle then across the marked apex that separates the entrance ramp and the right straight lane of southbound Interstate-95 then cutting in front of another vehicle that was traveling southbound on Interstate-95 in the right starlight lane. Cpl. Dallesandro's in car camera was on and recorded video of the vehicle's travel.

Cpl. Ballesandro then attempted to catch up to the white Dodge Charger. Cpl. Ballesandro stated that the white Dodge Charger veered all the way to the left into the left straight lane for southbound Interstate-95. Cpl. Ballesandro stated that the white Charger was traveling at a very high rate of speed. Moments later Cpl. Mike Ballesangdro was able to make a traffic stop on the white Dodge Charger on the left paved shoulder of southbound Interstate-95 just south of Donald Ross Road. Cpl. Ballesandro then met with the Dodge Charger's driver Mr. Matthew Ryan Shelley (FL DL # S-400-556-83-148-0). Cpl. Ballesandro then requested a State Trooper from the Florida Highway Patrol come to his traffic stop.

A short time later I arrived and spoke to Cpl. Ballesandro. Cpl. Ballesandro stated that the driver of the Dodge Charger was showing indicators of possibly being under the influence.

I then walked up the Dodge Charger and met with it's driver Mr. Shelley. I observed that Mr. Shelley had glassed over eyes, had slurred speech, emitted an odor of alcohol from his person, and had a flushed face. I asked Mr. Shelly where he was coming from where he stated from a friends house. I the asked to

where he was going after leaving friends house, he stated going to anthers friends house. Mr. Shelly stated while at friends house he drank two Captain Morgan and Cokes. I advised Mr. Shelley that he was showing indicators of possibly being under the influence and asked if he would submit to roadside soberly exercises. When asked again if he would submit to the exercises he stated that he would. Mr. Shelley exited his vehicle and walked over to my marked patrol vehicle with it's in car camera on.

The first exercise was H.G.N. (Horizontal Gaze Nystagmus). During the exercise Mr. Shelley exhibited lack of smooth pursuit, had distinct and sustained nystagmus on both right and left eyes, had onset of nystagmus prior to forty five degrees, and swayed.

The next exercise was the "Walk And Turn". A yellow in color in color tape was layed down on the concrete ground shoulder/ turn around slot. Mr. Shelley was wearing brown in color slippers. During the exercise Mr. Shelley performed an incorrect 180 turn on the incorrect foot (right).

The next exercise was the "One Leg Stand". Mr. Shelley stated that he did not have any medical issues that meant he count not perform the exercise. During the exercise Mr. Shelley put his right foot down on the count of 15 one thousand at about 29-30 seconds after starting the exercise.

Based on the evidence I placed Mr. Shelley under arrest for driving under the influence at 8:35pm, and placed him in the rear of my patrol vehicle. Short time later All Florida Towing towed the white Dodge Charger from the scene. I then transported Mr. Shelley to the Palm Beach County breath testing center at the Palm Beach County Main Jail. After a twenty minute observation Mr. Shelley went on camera at the testing center where I asked if he would submit to breath sample. Mr. Shelley stated that he would submit to the request. Mr. Shelley's two breath samples return a result of .138 and .135 g/210L. A short time later I took Mr. Shelley to the booking area of the Main jail.
