I also noticed a strong alcoholic odor emanating from that vehicle that grew stronger when Evans was talking. When I asked Evans if she knew where she was she was unable to give me a location other than she was in Wellington. It was at that point that I noticed that there was a young juvenile sleeping the in backseat of the vehicle without any car seat. Additionally I noticed approximately ten candy wrappers on the ground outside the driver side rear window. The juvenile would later be identified by her mother Maureen as Giavana Evans (DOB 07/28/2015). Maureen Evans showed signs of possible impairment so I requested a DUI Unit to conduct an assessment. DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Sunday May 23, 2021 at approximately 2308 hours I was dispatched to the 13600 hundred block of Yarmouth Court, Village of Wellington, Palm Beach County Florida regarding a suspicious vehicle with a possible impaired driver. Upon arrival I met with D/S G. Palmer # 25514 who provided me with a supplemental probable cause affidavit stating: "On May 23rd, 2021 at approximately 2303 hours while on routine patrol in the area of 13659 Yarmouth Ct. in the Village of Wellington when I observed a black Honda Accord bearing FL Tag DZM1J stopped with the engine running and the vehicle on the roadway obstructing what would be the flow of traffic if there was any at the time. Believing it was possible the vehicle was waiting for someone I attempted to pass the vehicle on the left. While passing the vehicle I observed a white female who would later be identified by her not valid FL DL as Maureen Evans, in what appeared to be her sleeping behind the wheel. Concerned for Evans wellbeing I honked my police horn in order to try and wake her up. When that failed I exited my vehicle and knocked on the window several times until she woke up. When she woke up I noticed that she was sweating to the point her hair was damp, her eyes appeared to be glossy and bloodshot, her speech was slurred and lethargic. I also noticed a strong alcoholic odor emanating from that vehicle that grew stronger when Evans was talking. When I asked Evans if she knew where she was she was unable to give me a location other than she was in Wellington. It was at that point that I noticed that there was a young juvenile sleeping in the backseat of the vehicle without any car seat. Additionally I noticed approximately ten candy wrappers on the ground outside the driver side rear window."

OBSERVATION OF DRIVER:

I observed the driver to be unsteady on her feet. The defendant had a noticeable orbital sway as she stood. The defendant's clothing was properly worn. The defendant's eyes were red, glassy, and bloodshot. The defendant's speech was slow, slurred, and quiet. The defendant stated she was very nervous and was shaking.

DRIVER'S STATEMENTS:

The defendant denied consuming alcohol. The defendant stated that she picked up her daughter from her friends house on Yarmouth Drive earlier in the evening and that she was going home.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage coming from the defendants breath, which intensified when the defendant spoke.

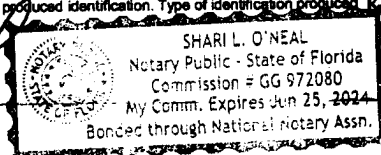

The defendant was given instructions and a demonstration. The defendant did not keep both legs straight. The defendant did not look at her pointed toe as instructed. The defendant used her arms for balance by squeezing her hands against her legs causing her arms to be tense. The defendant did not count aloud. The defendant had a noticeable orbital sway during this task.

FINGER TO NOSE:

The defendant was placed into the instructional stance for the Finger to Nose. The defendant was instructed to not move from the instructional position until told to do so. The defendant was given instructions and a demonstration. The defendant had to be reminded to keep her eyes closed. The defendant searched for her own nose with her finger. The defendant did not touch tip to tip as instructed. The defendant had a noticeable orbital sway during this task.

ROMBERG ALPHABET:

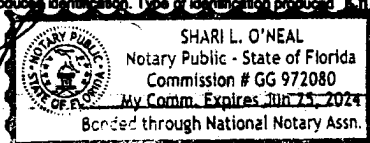

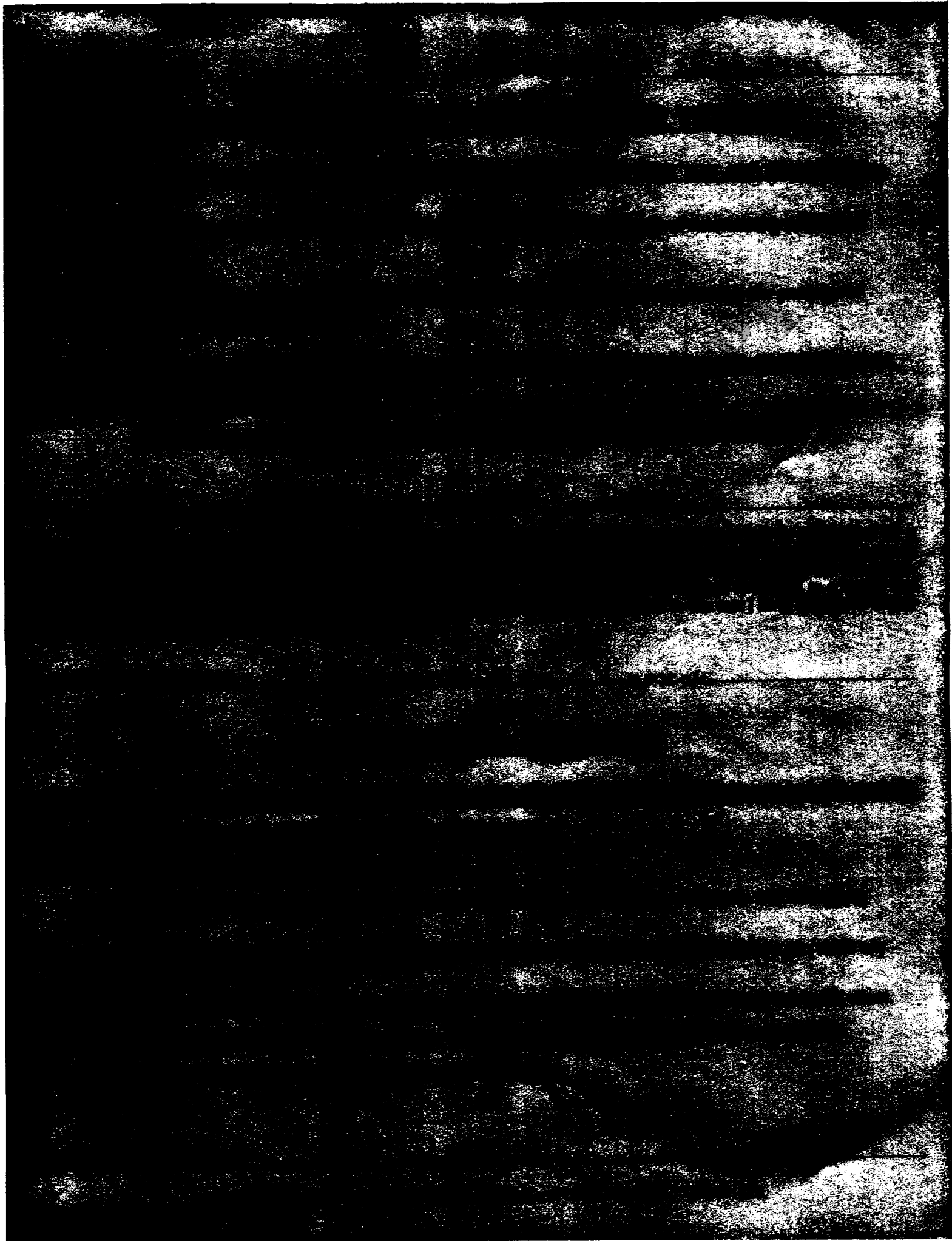

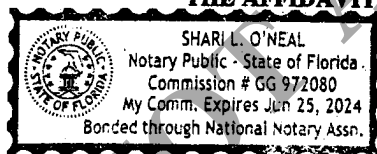
