The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was stopped for driving with a suspended driver's license. The defendant was driving his 2018 Land Rover, bearing FL tag #K94DD. Upon making contact with the defendant, affiant noticed he displayed multiple indicators of impairment, including: slurred speech, a distinct odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, sluggish reflexes, difficulty dividing his attention, and repetitive questions. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .125/.124.

The defendant identified himself via his FL driver's license.
