The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a gray 2019 Toyota Tacoma pick up truck, Florida tag DCMN27. The defendant failed to stop for a properly posted stop sign. The defendant entered the intersection and struck a white 2014 Subaru Crosstrek, 4 door, Alabama tag 47CF115, on the passenger side front quarter panel. Estimated damage to the Subaru is \$5,000.00. This was witnessed by me as I was traveling behind the Subaru. The defendant was the sole occupant of the truck and was witnessed by me exiting the driver side front seat. The defendant was advised the civil traffic crash investigation was complete and a criminal DUI investigation was being conducted. The defendant was advised of his Miranda Rights. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his movements were calculated and lethargic. The defendant swayed while standing, and had difficulty following simple instructions. The defendant initially denied alcohol consumption but then stated he drank one alcoholic beverage earlier today. The defendant's time perception was off as he thought it was 11:30 PM, and the actual time was 3:20 AM. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purposes of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
