The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 4/6/2019, at approximately 1842 hours, the defendant removed various makeup items from their packaging and concealed them on her person. The defendant also changed the price tag of a shower curtain for another shower curtain, valued at a lower price, and double packaged pillow cases. The total price for the merchandise was valued at \$137. The defendant then passed all points of sale without rendering payment for the items. The defendant was taken into custody. Upon a search of her person, the defendant possessed an unmarked pill container, filled with various medications and small clear plastic bags containing a white powdery substance, within her purse. The powdery substance was tested via a field reagent test kit which tested positive for cocaine. Two and a half light green, oval pills with the mark "S 902" was identified to be Alprazolam (1 mg/pill). Two and a half gray, round pills with the mark "K 57" was identified to be Oxycodone Hydrochloride (20 mg/pill). Both pills were identified via Poison Control Operator Brown #9. The defendant was identified by loss prevention as the person who committed the offense. The defendant was also identified via her Florida driver's license.
