The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 7/11/2021, at approximately 0700 hours, a [REDACTED] defendant arrived at the residence to make contact with her husband who was staying with his family. The defendant was let into the residence and started demanding the victims tell her where her husband was located. The defendant did intentionally and unlawfully threaten to do violence to the male victim by telling him to "shut the fuck up" and pointing a handgun to the front of [REDACTED]. The defendant immediately went to the female victim, pointed a gun at [REDACTED] and then used her fist to punch [REDACTED]. At the time the defendant appeared to have the ability to carry out the threat. The act of the defendant created in the mind of the victims, a well founded fear that violence was about to take place. The assault was made with a deadly weapon. The victims positively identified the defendant as the person who committed the offense. The defendant was also identified via the HCSO database. The victim's were able to disarm the defendant during the incident. Upon making contact with the defendant she had a holster and a spare magazine to the handgun in her possession.
