 Officers were called to the Armature works parking lot reference the defendant who appeared to be intoxicated and was trying to leave in her gray Dodge Dart (IA EXN381). The made contact with the defendant who was sitting in the drivers seat with the engine running. During observations she had red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on her breath.
