The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a brown 2018 Mazda four door bearing a Florida license plate of 1WKU87. She was traveling west on Kennedy Blvd and swerving back and forth, then traveled south on Himes Ave and was swerving back and forth again, striking the curb. The vehicle came to a stop for a red light at Henderson Blvd and made a right turn on a red light, at a posted "No turn on red" intersection. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (one beer). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .226 and .216. The defendant was identified by her FL DL.
