The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 5/22/2020, at approximately 2345 hours, while traveling south on interstate 275 south, I observed a grey Honda Civic bearing Florida Tag #LFJN55 and VIN #19XFC2F83KE010221 traveling south in the far left lane. While I was traveling in the middle lane, I observed this Honda almost collide with the far left concrete barrier 2 times. The Honda swerved from the far left emergency break down lane (to the left of the yellow line) over more then halfway into the middle lane (directly in front of my marked patrol vehicle) 3 times. I conducted a traffic stop on the 275 southbound bridge approximately 1/4 way across the bridge and within Hillsborough County. The boyfriend of the defendant and vehicle registered owner was placed under arrest for DUI by Deputy Clark ABN #253212. The defendant was also showing signs of impairment and advised she would call for a ride rather then attempt to drive her boyfriend's vehicle. I conducted an inventory search of the vehicle, subsequently locating a clear bag which contained multiple pills, consistent with MDMA pills (on the passenger front floor board next to the base of the seat an next to the defendant's purse which contained her Driver's License. A field reagent test kit was positive for MDMA. The defendant spontaneously stated "if those were mine, what would happen to me?". I confirmed the defendant's identity via DAVID photo.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
