The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 09/29/2021, at approximately 2034 hours, I responded to 904 15th St NE, to investigate a hit and run traffic crash (DHSMV #24626913). While conducting my investigation, I learned the vehicle which left the scene, bearing FL Tag DWZX78, was registered to the defendant at 1505 Harbor Blue St. While speaking to the defendant in reference to the traffic crash, the defendant unlawfully and intentionally struck your affiant in the chest with an open hand, while stating get out of my house. The defendant then attempted to close the door on your affiant which struck your affiant in the right arm and leg. During the process of a show up regarding the traffic crash, the defendant removed her right handcuff and then resisted your affiant's attempt to place her back into custody. The victim and witness of the crash identified the defendant as the driver. The defendant's identity was confirmed via her DAVID photograph.
