

Probable Cause

I, Officer Defeo, of the Florida Fish and Wildlife Conservation Commission (FWC), was on patrol in my marked patrol truck. I was traveling north on 180th Ave N in Loxahatchee, County of Palm Beach, when I observed 3 vehicles stopped at the stop sign on 180th Ave. N and Valencia Blvd. The vehicles stayed stopped as I

approached them. I then made a right-hand turn onto Valencia Blvd and the last vehicle (105NKS) flagged me down. The driver stated the White van in front of him drove into oncoming lanes of traffic, almost getting into several accidents. He also said the driver drove off the road onto several driveways coming down Valencia Blvd.

The two front vehicles pulled onto 180th Ave and stopped. I turned my patrol truck around, pulled behind the white van and activated my blue lights. I exited the vehicle and approached the driver side window to conduct a welfare check of the driver to ensure she was not having some sort of medical episode. As I began speaking with the operator, Melinda J. Rigdon, I noticed that her speech was severely slurred. I then asked her for her driver license, registration, and insurance at which point I detected a moderate smell of an alcoholic beverage coming from her breath. As Rigdon was searching for the requested items, she was fumbling carelessly through her pocketbook, at one point she could not get her zipper open and then handed it to me to open it for her. She continued to fumble around and could not find her driver licenses.

I had Rigdon stay seated in her vehicle while I requested a Palm Beach Sheriff's Office (PBSO) D.U.I. unit. Dispatch notified me that PBSO did not have a unit available, so I began a D.U.I. investigation.

Based on the observed signs of impairment and the statements from independent witnesses I requested Rigdon exit the vehicle to conduct standardized field sobriety tasks. She complied as she walked to the rear of my patrol truck, she was unsteady on her feet. The task conducted, and the observations made are listed below.

Based on my observations and Rigdon's poor performance on the field sobriety tasks, Rigdon was placed under arrest for driving under the influence while her normal faculties were impaired. Once at the BAT a twenty-minute observation was conducted and Rigdon was asked to provide a sample of her breath as required by law. She refused.







I was traveling north on 180th Ave N in Loxahatchee, County of Palm Beach, when I observed 3 vehicles stopped at the stop sign on 180th Ave. N and Valencia Blvd. The vehicles stayed stopped as I approached them. I then made a right-hand turn onto Valencia Blvd and the last vehicle (105NKS) flagged me down. The driver stated the White van in front of him drove into oncoming lanes of traffic, almost getting into several accidents. He also said the driver drove off the road onto several driveways coming down Valencia Blvd.

The two front vehicles pulled onto 180th Ave and stopped. I turned my patrol truck around, pulled behind the white van and activated my blue lights. I exited the vehicle and approached the driver side window to conduct a welfare check of the driver to ensure she was not having some sort of medical episode. As I began speaking with the operator, Melinda J. Rigdon, I noticed that her speech was severely slurred. I then asked her for her driver license, registration, and insurance at which point I detected a moderate smell of an alcoholic beverage coming from her breath. As Rigdon was searching for the requested items, she was fumbling carelessly through her pocketbook, at one point she could not get her zipper open and then handed it to me to open it for her. She continued to fumble around and could not find her driver licenses.

I had Rigdon stay seated in her vehicle while I requested a Palm Beach Sheriff's Office (PBSO) D.U.I. unit. Dispatch notified me that PBSO did not have a unit available, so I began a D.U.I. investigation.

Based on the observed signs of impairment and the statements from independent witnesses I requested Rigdon exit the vehicle to conduct standardized field sobriety tasks. She complied as she walked to the rear of my

Disposition of Operator and Vehicle

The vehicle was turned over to her cousin, at the scene, at Rigdon's request. When asked at the jail about where she was coming from and what she had to drink, Rigdon gave different answers than what she stated at the scene. She responded with a location of Kokomo's and she had been drinking Bloody Mary's. Her previous answers were the Brass Ring and Wine. 
