The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the listed date and time, Deputy J. Fargo (ABN:257830) contacted the driver on a traffic stop for failure to maintain a single lane. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage from her breath and she had bloodshot and watery eyes. The affiant requested the defendant to perform Field sobriety exercises (SFSEs) which she agreed to do. During the SFSEs additional indicators of impairment were observed and the driver was subsequently arrested for DUI. After a proper 20 minute observation period was conducted the defendant agreed to provide two lawful breath samples of her breath. breath technician D. Jones (ABN:255934) provided the affiant with the results and they are as follows: first BrAC sample .171%, Second BrAC sample .182% . The defendant admitted having consumed 2 margaritas prior to the traffic stop tonight during post-Miranda interview. The defendant was identified via her valid Florida driver's license.
