The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 7/19/2020, at approximately 0058 hours, I arrived at Fowler Ave and Morris Bridge Road. I observed a black in color vehicle upside down on the side of the road. The vehicle had collided with a road sign and utility pole sustaining heavy damage. I then contacted driver who was sitting on the ground. Upon contacting the DEF/driver (Melissa Gonzalez Montero), I could smell a strong odor of an alcoholic beverage emanating from Gonzalez Montero's exhaled breath. Gonzalez Montero also had bloodshot and glassy eyes and advised she had a few drinks. Upon talking with Gonzalez Montero, she had slowed speech and when asked to walk, she had difficulty. Saul Figueroa, who was on scene during the crash, advised he watched Gonzalez Montero crawling out of the driver side window. I asked Gonzalez Montero if she would complete SFSE's to which she responded, "yes". However, she only completed the walk and turn exercise. Following that exercise Gonzalez Montero ran from the spot where we were conducting the SFSE's and attempted to reenter her vehicle. She had to be forcibly removed from her vehicle. Due to the results of the exercise and her refusing to complete the remaining exercises, I placed the DEF under arrest and transported her to CBT. At CBT she was turned over to a breath test operator and she provided the following breathe test results: 159 and a .156.
