I § 18(b) On Wednesday May 11, 2022, at 1229 hours, as an Agent assigned to Palm Beach County Sheriff's Office District 7, unincorporated Boca Raton, Florida, Street Crimes Unit, I was patrolling the area of St Andrews Ave and Glades in reference to an (Be on the Look Out) issued by Real Time Crime Center. RTCC issued the BOLO for a 2008 black BMW 335 with North Carolina Tag number HHV3252 that was reported stolen at Orange County Sheriff Office (case number 22026441) on 04/27/2022. I then observed the above listed vehicle traveling northbound on St Andrews Ave toward Glades Road. The BMW was occupied with a white female that was later identified by Florida Driver License as Melissa Cupp. I advised Dispatch that I located the vehicle and Sgt [REDACTED] requested additional resources. I followed the Cupp who was driving the stolen BMW until she came to a stop at 8211 Lawson Bridge Ln, Delray Beach, FL 33446. Cupp exited the driver side of the vehicle and walked up to the residence. I then made contact with Cupp, identified myself and advised Cupp the reason for the contact. Cupp was placed into handcuffs that were checked for proper fit and double locked. Cupp was read Miranda rights from a department issued Miranda rights card, stated she understood and was willing to speak to me without an attorney present. Cupp stated she had some type of monetary transaction with her ex-boyfriend for the vehicle but had not put the vehicle in her name. Cupp stated the North Carolina tag did not belong on the vehicle and it was from her old vehicle. Cupp stated she had a domestic dispute with the owner of the vehicle and then took the vehicle the following day. Cupp stated she knew the vehicle was reported stolen. I made contact with YanCarlos Huertas the owner of the vehicle. Huertas stated he and Carlos Vasquez Jr reported the vehicle stolen and still wanted to prosecute for the theft.
