 Knowing and unlawfully commit the offense of DUI, to wit:

The defendant was operating a 2012 black in color Ford four door bearing Florida Tag# INRE40, while traveling northbound on Howard Av N at North B St W. The defendant was observed drifting/driving on lane lines several times and she also struck the curb with the passenger side front/rear tires several times.
