Before me this date personally appeared GERLOCK, GARRETT G. (PD0969) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 9000 W SAMPLE RD, CORAL SPRINGS, FL 33065 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

TRAINING AND EXPERIENCE, I RECOGNIZED THE ODOR OF FRESH CANNABIS COMING FROM WITHIN THE VEHICLE. ALL OCCUPANTS INCLUDING THE ABOVE LISTED SUBJECT, WERE REMOVED FROM THE VEHICLE SO THAT A NARCOTICS SEARCH COULD BE CONDUCTED.

AS THE SUBJECT OPENED HER DOOR, I NOTICED A CLEAR PLASTIC CUP IN THE FRONT PASSENGER SIDE DOOR PANEL CONTAINING A GREEN LEAFY SUBSTANCE WHICH I IMMEDIATELY RECOGNIZED TO BE CANNABIS BASED ON MY TRAINING AND EXPERIENCE. BASED ON WHERE THE CUP WAS LOCATED, IT WOULD HAVE BEEN OBTAINABLE ONLY BY THE PERSON SEATED IN THAT FRONT PASSENGER SEAT.

THE SUBJECT WAS SEARCHED BY DET. EASON. DET. EASON INFORMED ME THAT SHE LOCATED A CLEAR PLASTIC BAG CONTAINING A SINGLE YELLOW RECTANGULAR SHAPED PILL HIDDEN INSIDE THE SUBJECTS SPANDEX PANTS, NEAR THE AREA OF HER RIGHT HIP.

DURING A SEARCH OF THE VEHICLE SEVEN (7) ADDITIONAL ALPRAZOLAM TABLETS WERE LOCATED IN A PLASTIC BAG IN THE CUP HOLDER NEXT TO WHERE THE SUBJECT HAD BEEN SEATED. THE ABOVE LISTED SUBJECT WAS ALSO CHARGED WITH CONSTRUCTIVE POSSESSION OF THOSE ALPRAZOLAM TABLETS AS WELL.

POISON CONTROL CONFIRMED (CASE NUMBER M3562477) THE PILL TO BE AN ALPRAZOLAM (ALSO KNOWN AS XANAX) 2MG TABLET.

THE SUBJECT WAS PLACED UNDER ARREST AND CHARGED WITH THE POSSESSION OF ALPRAZOLAM (XANAX) AND CANNABIS LESS THAN 20 GRAMS.
