 The defendant, who has no military affiliation, entered Macdill AFB through the Dale Mabry Gate without stopping for the Sentry. The defendant, who was identified by her Florida Driver's License, was stopped inside the base by Military Police. The defendant had slurred speech, an odor of an alcoholic beverage emitting from her breath and difficulty maintaining her balance. The defendant had thrown up inside her car. When I arrived on scene I requested the defendant perform some SFST's and she consented. The defendant was unable to perform SFST's satisfactorily and post Miranda, admitted consuming 3 glasses of wine before driving. I arrested the defendant for DUI and transported her to CBT. Once at CBT I requested the defendant submit a breath test. The defendant, who according to DAVID had a prior DUI with a breath test refusal in 2019, once again refused to provide a breath sample. The defendant was subsequently charged with the refusal. This occurred in Hillsborough County, Florida.
