On 03/01/2021 at approximately 1200 hours I was assigned to follow-up on a previously reported vandalism call ref PBSO case 21-040079. On 02/27/2021 at approximately 2130 hours, victim David Brams called and reported his gray 2017 Ford Explorer bearing FL tag ARKY28 had been vandalized. The vehicle was parked in David's assigned parking spot (#22) in the Cannonsport parking garage, which is located at 180 Lake Dr, Palm Beach Shores, FL. The vehicle had been "keyed" and CPL. L. Blasco I.D. 9500 observed deep scratches in both the passenger and driver's side door area. When David made the original report he did not have any suspect(s) information and the case was inactive.

David later discovered he had a Garmin Dash Cam mounted on the windshield of his vehicle. The camera is activated after detecting motion and in this case recorded the suspect vandalizing David's vehicle. The camera footage showed the following: On 02/27/2021 at 1817 hours a W/F is seen walking in front of the vehicle and traveling to the passenger side. David identified the W/F as Melissa Sun, who lives in the same condominium building. Melissa then uses an unknown object to scratch the passenger side door. Melissa then walked across the front of the vehicle to the driver's side door where she again used an unknown object to cause significant scratches in the vehicle's paint.

Melissa is seen on video nervously looking over her shoulder and laughing while damaging David's vehicle. Melissa has previously cursed at David over his use of a drone and they had an altercation approximately 1 hour before Melissa damaged David's vehicle. Photos of the vehicle's damage, the video footage, and a sworn written statement from David requesting criminal prosecuting were placed into evidence.

On 03/01/2021 D/S P. Africano I.D. 36146 conducted a photo lineup with David. David selected Melissa out of a 6-person photo array positively identifying her as the suspect. David also obtained two quotes for the damage repair. Al Packer Ford and Dave's Auto estimated the damage at well over \$1,000, making this criminal act a felony per FSS. Both written estimates and the photo array were placed into evidence.

After conducting my investigation, reviewing physical evidence, and speaking with the victim, I determined def. Melissa Sun willfully and maliciously damaged personal property belonging to David Brams, which is a violation of F.S.S 806.13(1)(b)(3). This case is cleared by arrest.
