The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 02/09/2020 at approximately 1233hrs, Affiant observed a 18' yellow/white Proline center console boat bearing FL7702GW / PLCS025G990 violating the posted idle speed sign located at the mouth of the Alifia River located at 9425 41 Hw S Tampa, Hillsborough County, FL 33578 (Citation V469528). Upon stopping the vessel, affiant made contact with the operator / defendant, who was standing behind the helm of the vessel with both hands on the steering wheel. During personal contact with defendant, affiant detected a strong odor of an alcoholic beverage coming from his breath as he spoke and observed him to have blood shot watery eyes. Due to this, I advised the defendant I had a suspicion he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance and that I would like him to perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the exercises. After observing signs of impairment, affiant arrested the defendant for BUI and secured him in handcuffs. Affiant then advised the defendant of Florida Implied Consent. The defendant stated he understood and would provide a breath sample. The defendant was transported to central breath testing located at the Orient Road Jail. After a 20 minute face to face observation period, the defendant blew .093 / .096. The defendant verbally identified himself and was identified by a Florida driver's license photo.
