The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On December 17, 2019 At approximately 2321 hours while on patrol in my marked Florida Highway Patrol unit, in Hillsborough County Florida I was radio dispatched to a vehicle crash on State Road 580 just west of Webb Road. Upon my arrival on scene I was met with several Hillsborough County Deputies who advised they observed some signs of impairment for Driver 1 Ms. Menchu Demontfort. While on scene I spoke with the driver of the vehicle Menchu Demontfort. I identified the driver via her Florida Driver's License # D553540725290. She advised that she was driving the vehicle and was the sole occupant. While speaking with Ms. Demontfort I observed indicators of impairment, slurred speech, orbital sway, trouble locating documents, and trouble walking from one point to the other. Ms. Demontfort almost fell do to being unbalanced. I advised Ms. Demontfort of her Miranda rights at approximately 1156 hours. I advised Ms. Demontfort, I had concluded the crash portion of this investigation and would be transitioning to a criminal investigation for driving Under the Influence. Ms. Demontfort advised she was on her way to a sleep study at St. Joes outpatient Hospital. Prior to operating the vehicle, she ingested her percribed sleeping aid medication designed to assist her in sleeping along with several other medications for depression. I asked Ms. Demontfort if she would be willing to perform Field Sobriety Exercises and she agreed to perform Field Sobriety Exercises (FSE's). Ms. Demontfort performed poorly on FSE's. At approximately 0028 hours Ms. Demontfort was placed under arrested and charched with Driving Under the Influence, and Careless driving. I transported the I transported Ms. Demontfort to the Orient Road Jail Central Breath testing and asked her if she would provide a Urine sample and a breath sampe to help determine blood alcohol content and/or the presence of chemical or controlled substances. The Ms. Demontfort agreed provide a both a breath and urine sample.
