The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 04/28/2020 at approximately 2324 hours, while at 204-14721 Longview Dr, the defendant and victim were in a verbal altercation which turned physical when the defendant pushed the victim several times against his will while in the kitchen of their residence. The defendant punched the victim in the face one time and scratched the victim's neck. While the victim was picking up an Xbox off the ground, the defendant used her foot to push the Xbox down which caused several lacerations to the victim's left hand. Post-Miranda, the defendant denied touching or striking the victim at all. The defendant and victim are in a domestic relationship and live together as a family. The victim identified the victim as the one who committed the offense. The affiant confirmed the defendant's identity via her Florida driver's license photograph.
