The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 14 day of NOVEMBER, 2019,

at approximately 1:34 AM, at FOREST LAKES BLVD / MEARS BLVD, in Pinellas County did:

REASON FOR STOP: WHILE TRAVELING SOUTH ON MCMULLEN BOOTH ROAD NEAR MAIN STREET, I OBSERVED A DARK COLORED SEDAN TRAVELING NORTH AT A HIGH RATE OF SPEED. I VISUALLY ESTIMATED SPEEDS TO BE IN EXCESS OF 90 MILES PER HOUR IN A 45 MILE PER HOUR ZONE. I MADE A U-TURN IN AN ATTEMPT TO CATCH UP TO THE VEHICLE AS IT WAS APPROACHING ENTERPRISE ROAD. WHILE ATTEMPTING TO CATCH UP TO THE VEHICLE I OBSERVED THE VEHICLE WEAVING IN AND OUT OF TRAFFIC LANES PASSING OTHER MOTORISTS. I ADVISED PATROL UNITS OF MY OBSERVATIONS, VIA RADIO. DEPUTY BLAKE OBSERVED THE VEHICLE AND VARIFIED THE SPEED IN EXCESS OF 100 MILES PER HOUR. THE VEHICLE MADE AN EAST TURN ONTO STATE ROAD 580 WHERE IT CONTINUED TO SWERVE BETWEEN LANES AT A HIGH RATE OF SPEED. THE VEHICLE WAS INTERCEPTED AT FOREST LAKES BLVD AND MEARS BLVD. THE DRIVER OF THE VEHICLE WAS IDENTIFIED AS XAVIER MERCEDES.

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED.

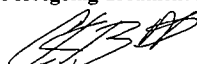

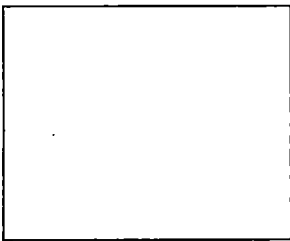
