


I observed a white male astride a three wheeled bicycle northbound on 68th Terrace N, approaching W Indiantown Road, with a female passenger riding on the back, straddling the male. The bicycle was equipped with lights to both the front and rear, but neither was activated. I conducted a traffic stop on the pedalcycle in the parking lot of the McDonald's at 6760 W Indiantown Road. I identified the male subject as Michael Holder (DEFENDANT) and the female as Merri Southwell (CO-DEFENDANT). I am familiar with Holder and Southwell as they were recently involved in a traffic stop where a third passenger fled from me, and during that investigation I learned that both Holder and Southwell use heroin as well as fentanyl.

I asked Holder for consent to search his person and he consented. During my search of his person he had an odor of cannabis emitting off his clothing. Holder denied smoking cannabis or being around it. I know from my last investigation that Holder is not a medical marijuana card holder. Holder denied consent to search his bicycle, however due to the odor emitting off of his person I had probable cause to believe that it possibly contained marijuana. During a search of the handle bar bag, I located a used syringe with cap. I read Holder his Miranda rights from a prepared card and he agreed to speak to me. He admitted to the needle being his for the purpose of using heroin.

Southwell advised that she may have old paraphernalia in her purse but was not sure. She consented to a search of her purse. Inside of her purse, I located a used syringe with a cap. I read Southwell her Miranda rights from a prepared card and she advised that she understood her rights. She admitted to the needle being hers.

Based on my investigation I have probable cause to charge both Southwell and Holder for possession of drug paraphernalia, contrary to F.S.S. 893.147(1). Both subjects were placed under arrest and released from the scene with a court date (NTA) of 6/2/2021 at North County Courthouse. Holder was given a written warning for the bicycle light infraction. I submitted both needles to JPD evidence. BWC.
