The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 9/7/2021, at approximately 2142 hours, Affiant observed a grey Subaru bearing FL tag PGMK49 (VIN:JF1GE6B61AG516323) traveling eastbound on Hillsborough Av W from Silvermill Dr. The grey Subaru was measured traveling 78MPH in a posted 50MPH zone by the rear antenna of my HCSO issued BEE III DIRECTIONAL RADAR SYSTEM : S/N:BEE932000210. Affiant conducted a traffic stop on the vehicle at in Longboat Bl W / Hillsborough Av W , FL and observed the defendant operating the vehicle and to be the sole occupant. Affiant detected the distinct odor of an alcoholic beverage emanating from his breath, his eyes were bloodshot and glassy, and he exhibited fumbling fingers when retrieving vehicle documentation. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). The defendant was transported to Central Breath Testing (CBT) where he refused to provide a lawful breath sample to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of CBT, he understood and replied "I am refusing to provide breath." The defendant was identified via FL DL. The defendant was given a DUI citation A9IB45E which reflects the DUI charge. The defendant also received Uniform Traffic Citations AF2OHNE for Speeding (78MPH in a posted 50MPH zone), and AF2OHNE for Possession Of Open Container By Driver (black metal container on driver door containing liquid with the distinct odor of an alcoholic beverage emanating from its contents.)
