On the 19 day of July, 2020 at 22:39 (Specifically include facts constituting cause for arrest.)

On July 7, 2020, at approximately 2134 hours, I was dispatched to a loud music complaint at 325 Northlake drive in the city limits of North Palm Beach FL, 33408. Upon my arrival, I made contact with Michael Claude Lang (W/M DOB: 02/11/1962) I advised Mr. Lang about playing loud music out of his car which is disrupting his neighbor's sleep. Mr. Lang appeared very intoxicated, his speech slurred, and he was unsteady on his feet. He became agitated of my Field Training Officer's and my presence. Seeing this, I told Mr. Lang we were leaving and to keep it down. I also advised him (due to his intoxicated state) to go inside his residence and go to sleep. Mr. Lang started to speculate the caller was the neighbor across the street that he had issues with in the past. As I was walking away I can hear Mr. Lang yell, "Fuck you".

Taking into account Mr. Lang's level of intoxication, I drove around the corner and parked my patrol vehicle in a parking lot facing Mr. Lang residence. Within just a few minutes, I witnessed Mr. Lang walk across the street to 326 Northlake Dr. I then watched him walk up to a silver ford pickup truck in the parking lot, (Florida tag DTBN31). Unknown to Mr. Lang, my FTO and I were now standing behind him. I witnessed him start letting the air out of the front passenger tire. After witnessing this, I placed Mr. Lang under arrest. He was placed in handcuffs (double locked) and checked for tightness. Mr. Lang was searched prior to being placed in my patrol car and he was wearing gray shorts and a black T-shirt.

Based on my eye witness observations and the totality of the circumstance, probable cause exists to arrest and charge Michael Claude Lang (W/M DOB: 02/11/1962, with; F.S.S, 856.011 Disorderly Intoxication (1)? No person in the state shall be intoxicated and endanger the safety of another person or property, and no person in the state shall be intoxicated or drink any alcoholic beverage in a public place or in or upon any public conveyance and cause a public disturbance.

Mr. Lang was taken to the North Palm Beach police station for processing and later transported to the Palm Beach County Jail without incident.
