The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 08/01/2020 2328 hours I conducted a traffic stop on a black 2012 Audi sedan, FL tag 580TC, suspecting that the driver was either ill, fatigued, or impaired, after I observed the vehicle drifting from side to side and speeding up and slowing down as it traveled eastbound on Kennedy Bl W from Henderson Bl. Upon contact with the driver of the vehicle, defendant Michael Edward Conti, I observed that he had bloodshot watery eyes and as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. The defendant then admitted to drinking "one glass of wine" that evening. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 2343 hours. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .151/.151. I identified the defendant with a valid FL DL. He was the only one in the vehicle.
