at approximately 9:05 PM, at EAST BAY DR/BELCHER RD, in Pinellas County did:

REASON FOR STOP: DEF WAS THE LONE OCCUPANT OF A BLACK GMC SUV WITH FLORIDA LICENSE PLATE "CQK L10" THAT REAR ENDED A STOPPED VEHICLE AT A TRAFFIC LIGHT. THE DEFENDANT WOULD FLEE THE SCENE HOWEVER OCCUPANTS OF THE VICTIM VEHICLE GOT HIS LICENSE PLATE AND RECORDED THE DEFENDANT WALKING AROUND THE VEHICLE AFTER THE CRASH.

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED HAVING A BAL OF .15 OR GREATER.

OFFICER LOCATED THE DEFENDANT'S VEHICLE PARKED IN FRONT OF HIS APARTMENT. UPON CONTACT, THE DEFENDANT WOULD STUMBLE INTO THE DOOR WAY AND STAGGERED AS HE WALKED DOWN THE HALLWAY. WHILE SPEAKING WITH HIM, THE DEFENDANT HAD SLURRED SPEECH, BLOOD SHOT/WATERY EYES, SLURRED SPEECH, AND THERE WAS AN ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AS HE SPOKE. WHILE OBTAINING HIS BASIC INFORMATION THE DEFENDANT WOULD SPELL HIS NAME WRONG AND HAD TO SIT ON THE REAR BUMPER OF HIS VEHICLE FOR BALANCE. POST-MIRANDA, HE ADMITTED TO HAVING TWO BOTTLES OF BUD LIGHT AND TWO DRAFT BEERS OF BUD LIGHT AT CHILI'S PRIOR TO DRIVING. LATER HE FURTHER ADMITTED THAT HE HAD THREE SHOTS OF JAMESON ALSO AT CHILI'S. DUE TO THE DEFENDANT'S LEVEL OF INTOXICATION, IT WAS UNSAFE FOR OFFICERS TO CONDUCT WALK & TURN AND ONE LEG STAND. HE PROVIDED TWO VALID BREATH SAMPLES OF .276/280 BRAC.

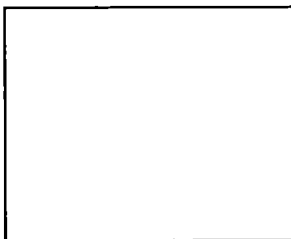
